# **CPRE Shropshire Campaign Briefing**

No 7: 10 July 2010

### 1. Welcome to Sarah Jamieson

## 2. Shrewsbury

**Your help needed to win North West Relief Road battle.** Shropshire Council's Development Services Scrutiny Panel will review the Council's involvement with the NWRR on 13 July at 7pm. Please attend to give a show of support. We will assemble outside Shirehall at 6.30 pm for banner waving and photos. Your presence at the meeting will remind councillors that we care about the landscape and tranquillity that this unnecessary road will destroy. County planners report that the recent consultation exercise shows increased public support for the road (agenda & papers: http://is.qd/dnbYJ).

**Tesco** are once again bidding for extra space for non-food items as their Harlescott store, after analysis by CPRE's Charles Green forced the retail giant to withdraw its previous application. CPRE Shropshire's Selby Martin said: "Tesco are describing this as an inadvertent breach but I think it is deplorable that a firm like Tesco should abuse its position and strength and push through an increase in comparison goods and sales space in conflict with the condition imposed on them and it shouldn't be allowed" (Star: http://is.gd/dl1bU).

**Incinerator.** The Battlefield incinerator proposal will be considered by Shropshire Council's Strategic Planning Committee on Monday 26 July at Meole Brace School, 2pm.

### 3. Oswestry: Keep Our Town Special

## 4. Marsh Christian Award for Oswestry Campaign

A few weeks ago, campaigners learnt that they had won the Group Award for campaigning within CPRE awarded by the Marsh Christian Trust. On Thursday, *Small Island* author and CPRE President Bill Bryson presented the award to Mike & Hilary Bullen, Charles Green and Wendy Clewes. Bill said: "When I came to this country I fell in love with the unique character and eccentricities of England's towns and countryside. ### 6. Landmark Polytunnel Ruling

Wye Valley Action Association has won a High Court ruling that polytunnels near sensitive sites must be subject to a Environmental Impact Assessment. The ruling recognised the impact of the development on the surrounding countryside, not just on the farmland where the polytunnels were erected. Paul Stookes for the WVAA said "There are real tensions in food production. We should be producing food locally, but you have to question whether we should be producing summer fruits in February." The NFU is to support a Herefordshire Council appeal against ruling in the Appeal Court in November (Guardian: http://is.gd/deVJb).

### 7. Coalition Government

Its been a dizzying few weeks for planning and the environment. The new government has announced new legislation but has been far from clear how much of the new planning system will operate. In brief:

**Out:** Housing targets, garden grabbing, housing density targets, National Housing and Planning Advice Unit, Commission for Rural Communities, Regional Strategies, Infrastructure Planning Commission, Regional Development Agencies, Housing and Planning Delivery Grant, pay as you throw charges, farming red tape.

**In:** Localism, Local Housing Trusts, Green Investment Bank, Local Enterprise Partnerships, Regional Growth Fund, simplified planning consent, incentives for communities to accept development, cooperation between planning authorities, housing energy retrofit, rural broadband, swingeing budget cuts to housing and much else.
