# President's report

Looking back over the last two years the word BREXIT has not been far from anyone's lips. I am writing this on the supposed eve of BREXIT, and we are non the wiser.

What is important now is that we have all the correct checks and balances in place that will safeguard our environment, landscape and countryside, whatever the future holds.

So much has happened and indeed is happening in the CPRE world, apart from the obvious ongoing conundrums produced by the planning system. Charles Green has reviewed not only planning applications across the county, but also commented on the Local Plan, which has been a Herculean task for one man. It has still yet to be completed! Thank you!

Turning to our wider activities in Shropshire; the lack of affordable housing is still a major issue and is exercising the minds of our management team. The provision of some affordable housing in our villages is still one of the great problems facing the countryside if our villages are to thrive and not just become somewhere that people retire to, or commute from. It will need younger people to become well established in a community. It is so often they who provide the energy and vision to allow a community to continue to thrive and of course help sustain the village school and other community facilities. The provision of a modest

number of well-designed homes, aimed at an affordable market, often makes a dramatic difference to any community.

Connor Furnival has been leading our war on litter, as part of CPRE's nationwide "Green Clean". This should be seen in the context of 35 million plastic bottles and 20 million aluminium cans sold nationally every day. We introduced a deposit return system to demonstrate to the drinks industry how it would work. The mobile reverse vending machine returned 10p for every drink container deposited.

There are many challenges and some uncertainty in the political world ahead. We are fortunate to have a passionate and knowledgeable management team, who are well able to be unofficial guardians of rural Shropshire, its landscape and communities. However, it is not just rural Shropshire that is under threat since urban green spaces, need nurturing and monitoring too.

Finally, a huge thank you to Sarah Bury, the management team at CPRE Shropshire and Sarah Jameson our dedicated administrator. They do so very much in their own time for the benefit of us all. Thank you!



# Chair's Report

**C**PRE has always worked to protect our countryside for the enjoyment and health of all the population not just for those living in the rural areas and today with so many threats and pressures for more housing and the loss of Green Belt, this message is even more important than ever. We need to encourage green spaces within our towns and improve access for all to the wider countryside. This is the message that we are getting from National Office and I like to think that we in CPRE Shropshire are doing our bit.

We have many partners with whom we work in Shropshire to promote these aspirations including the Shropshire Hills AONB, The Wildlife Trust and many Parish Councils. Visitors to Shropshire who support our local economy visit because we are still “unspoilt.” We have to work to make sure that we continue to draw in these visitors. We need to promote our market towns and villages with their wealth of listed buildings as well as the hills, meres and woodland. We are not against all development but we must fight to retain what is so unique in our built environment as well as our countryside and the part that it plays in giving the County its unique character.

Housing numbers always play a prominent part in our work and this year the threats to the Green Belt in the east of the county have been high on our agenda with proposals to build a Garden Village at Tong and a large increase in housing in Bridgnorth. These are proposals in the local plan which has just finished the first Consultation phase. We have also seen a proliferation in applications for industrial-sized poultry sheds, mostly in the South of the County. Not only can these

be inappropriate developments in the open countryside, but also they bring increased emissions from ammonia both from the buildings themselves and from the manure which is spread on the fields.

This year we have sadly said good bye to Roger Carlyle, our Vice President who with his wife Betty have been pillars of CPRE Shropshire for so many years. We are also losing Emma Jones, our Treasurer who recently married a farmer and as well as helping on the farm and having a full time job is now expecting a baby in July. Very many thanks to Emma for her commitment to CPRES over the last few years and the very best of luck with your new baby!

We have welcomed several new volunteers, some of whom have joined us on the Management Committee: Elizabeth Jones who comes from CPRE Kent and Susan Lockwood who has an interest in affordable housing and has represented us at National Office events. Greg Sinclair assists Connor in the Telford & Wrekin district and attends our management meetings. Linda Charais has just volunteered to take over the job of Treasurer. Hattie Thorpe-Gunner has recently joined the team for the photo competition and brings much-needed skills of PR and social media! We are very lucky to have such a strong team with so many varying skills as well as experience and wisdom.

I would like to thank my Vice Chairs, Cally Ware and Connor Furnival for all their support and Sarah Jameson, our Administrator for keeping us all together and sifting through reams of information to be passed on. Sarah is the major instigator of our new photo competition (see pages 8-11) and a keen photographer in her own right as can be witnessed in her continuous contributions to the website and to Shropshire Voice.

Finally I would like to thank Charles Green whose huge dedication to the detail of planning in the county is absolutely central to our work and, although not always agreed with, held in respect by those developing the Planning policies.

## Treasurer's report

**C**PRE Shropshire has had another very encouraging year in terms of financial fundraising, membership, and good use of our resources.

We increased our overall income position by £750 or so, although part of this was due to the increased revenue from AGM ticket sales this year, which is reflected in the higher AGM costs. It is very heartening to see that our income from membership has increased by around £370 or so, which reflects that CPRE membership is still seen as a way of protecting our landscape and county.

A precedent was set last year in 2017 to spend some of our reserves on expert consultants, and this was continued in 2018. This saw us spending £3,500 on consultants, which greatly bolstered our ability to put pressure on Shropshire Council and publicise this work in the media and press.

I hope that many of you enjoyed last year's AGM which was held on a glorious July evening at Attingham Park. It was a lovely event, allowing many members to enjoy a pleasant and informative evening. The costs of our AGM evenings has increased year on year since 2016, but this has been partially offset by successful ticket sales.

Overall, we spent £15,500 in 2018, reflecting a busy, but productive year. This left a deficit of £1,500, as originally agreed by the management committee at the start of the year. The same approach is also being taken in 2019 - with the same aim of using our resources to best effect to protect our wonderful Shropshire landscape.

# CPRE Shropshire Planning Update



## Local Plan Review

Those of you who responded to our call to submit responses will know that the consultation on the latest round of the Shropshire Council Local Plan review (on Preferred Sites) was extended by a week to 8<sup>th</sup> February 2019, because some of the necessary information was published late.

Our CPRE Shropshire response ran to 106 pages and argued that the housing targets should be reduced by at least 10%, the employment land requirement was grossly over-estimated and that half the proposed hub villages did not meet the Council's own sustainability requirements. We also continued to criticise the Council's approach to consultation and to sustainability issues. It is such a shame that it all seems to fall on deaf ears. We are told that there were several thousand responses this time, many from people who are particularly disgruntled by the Council's plans to build in the Green Belt.

It is the people around Bridgnorth, Shifnal and Tong who are chiefly affected by these plans to build in the Green Belt, which is supposed to be sacrosanct. There are the plans already on the table for 850 houses and other development at Stanmore, outside Bridgnorth.

And then there are the revised plans by the Bradford Estate to build something like 3,000 houses and 50Ha of employment sites near Junction 3 of the M54 to take

some of the unmet need from the Black Country and to assist RAF Cosford's expansion plans. These Junction 3 plans are not yet in the open, and are due to be consulted on in the summer, along with those at the Ironbridge Power Station site and at Tern Hill Barracks. But that hasn't stopped Shropshire Council from advertising all these sites on their *Invest in Shropshire* website, or from hawking them at an international property fair in Cannes.

There are meant to be "exceptional circumstances" before building occurs in the Green Belt, but these have yet to be put forward. The national rules require brownfield sites to get preference but these are obviously more costly to develop, so developers cry "viability". When one tries to get behind these viability reports "commercial confidentiality" is brandished as a means of preventing any meaningful checking of the figures. Readers may remember that we have had previous reason to doubt the Council's mathematical competence.

After this summer's consultation on the "strategic sites" the next and last stage of the Local Plan Review will be the "deposit" of the draft final plan, followed by six weeks of consultation before it gets "Examined in Public" under a Government Planning Inspector. That will be our last chance to show whether the Plan might be "unsound", before it gets adopted.

## Ongoing planning matters

As well as keeping up with the Local Plan Review, we keep our eye on all the planning applications on a weekly basis. There is a weekly press notice in the Shropshire Star of certain applications, but we also trawl through the Council's planning website and produce an edited list of the more important or interesting applications and decisions on a weekly basis. There are also the other ongoing planning campaigns to keep abreast of, including these:

### *Intensive poultry units*

We have recently teamed up again with colleagues in Powys and Herefordshire, and with other campaigners around Shropshire to see what can be done to stem the tide of poultry units which threaten wildlife and the public with cumulative ammonia emissions. We are taking forward a more comprehensive mapping project which should help to show the full extent of the situation.

## *Shrewsbury Growing Forward*

This group of councillors and local bodies sprang up because of the general cry from around the county (and indeed the country) that housing estates are plonked down without the proper infrastructure to create a "place" worth living in.

Shropshire Council is holding a series of "Place Plan" meetings which are ostensibly meant to address infrastructure issues but they are for only Town and Parish Councillors. Since 2012, over £26m of Community Infrastructure Levy (CIL) has been collected from house building, but not much of it has yet been spent on actual infrastructure. Shropshire Council do not seem to have fully grasped the potential of these CIL funds.

4) All images submitted must be the work of the individual submitting them and must not have been published elsewhere or have won a prize in any other photo competition.

## **SUSAN LOCKWOOD**



# District reports

## SHREWSBURY

The Shrewsbury Group has met five times since CPRE Shropshire's AGM in June 2018 and matters of interest have included:

A meeting with Daniel Kawczynski MP for Shrewsbury & Atcham with CPRE Shropshire's Charles Green and Roger Carlyle, was convened to discuss the ramifications of the Shropshire Local Plan Review document, with a specific mention that the number of new homes suggested for Shrewsbury is considered too high.

North West Relief Road – although Daniel Kawczynski is claiming the Government's pledge of £51M towards this project a success, doubt remains that Shropshire Council will be able to provide the finance needed to complete the project. The main objections are air quality, noise and traffic chaos around the major road junctions.

Poultry farm applications are monitored.

CIL – the Community Infrastructure Levy – Shropshire Council's response to concerns raised via SALC (Shropshire Association of Local Councils) will be monitored.

The over-riding concern regarding developments in rural areas are potential flooding and stress on local infrastructure, as well as transport, schools and GP surgery provision. Monitoring applications when they occur will continue.

Susan Lockwood attended a first-of-its-kind Network Event at CPRE National Office in London in March, entitled Affordable Housing in Rural Areas. There was a well-informed and examples of successful campaigns in the South of England and Cumbria. Robin Thompson, President, CPRE Shropshire, described how South Shropshire Housing Association came into being. The next step is to convene every group involved in creating affordable homes, in one place to explore how this goal could be achieved. For the Shrewsbury District the need is to recruit volunteers to carry this forward.

## TELFORD & WREKIN

The last 12 months for the Telford & Wrekin district have been mainly focused on growing our volunteer base and sending a positive message to the community about our organisation and its work and investing in the growth of the organisation locally.

In September 2018, we ran a very successful "Green Clean" in Telford Town Park which reached regional media channels and saw a variety of new groups work with us who we have never previously worked with. We collected nearly 1,000 recyclable items in the local nature reserve of the Town Park while we campaigned for a reverse vending machine system to be implemented nationwide. Particular thanks go to the Friends of Hollinswood & Randlay Valley and the Friends of Telford Town Park and Telford & Wrekin Council staff for their help.

Our district AGM in December 2018 was a great success with guest speakers John Box a local ecologist and Tina Corfield a Shropshire photographer. The AGM was well attended and the speakers were of a very high standard and shared their passions for our beautiful countryside and green urban spaces. From the success of the event we gained two new Parish Councils as members and a few new individual members. Connor Furnival was re-elected as Chair for 2019, with Greg Sinclair and Pauline Soulsby returned as Vice Chair and Secretary respectively.

We are currently planning for more events through 2019 and are looking at positive ways to work with Telford & Wrekin Council and other partners to give a holistic approach to better planning for future developments in the Borough.

I feel that Telford, while in the ceremonial county of Shropshire is a very different beast to the rest of the county. It is split down the middle with a half rural and half urban Borough but with positive planning I believe we can capture and seize this unique image for tomorrow's generation. But we need our message to grow and our aspirations to turn into action, it is this reason I am a part of CPRE and I look forward to our charity's future.

## OSWESTRY

As reported in earlier editions of Shropshire Voice we held a well-attended District AGM and talk in September last year. An AGM and Garden evening is being planned for late August this year.

Oswestry members, like others around the County, have been engaging with the effects of Shropshire Council's Local Plan review in our area. The Council are planning a mini-garden village at Park Hall in the name of the local Civic Society's ideas for "Oswestry 2050" but have missed the point of those ideas, which was for an overall Masterplan for the area.

Campaigns sometimes have to rumble on for years, of course. We still support the Oswestry Hillfort group in their long-running efforts to keep up awareness of the national importance of this "Maiden Castle" of the midlands, and of preserving its setting. At least there are no more plans currently to build around it, but the contentious site on Whittington Road will become visibly active soon.

Meanwhile the cranes have arrived at the Oswestry livestock market site to begin building the Morrisons store and petrol station, even as petrol cars are on the way out, and even after two other supermarkets have sprung up between that site and the Town centre. So much for protecting the high street.

And we still don't have the final result of the battle to keep giant pylons from marching across our patch. The Public Inquiry finished some five years ago, but its aftermath has definitely been kicked into the long grass whilst Government lawyers wrestle with Brexit issues.

## BRIDGNORTH

This has been a very active year for the Committee, mainly in challenging controversial planning applications that have taken a great deal of time to consider.

The planning lists supplied by the management committee have been most helpful in alerting us to those problematic applications that need investigation to ensure our local countryside is satisfactorily protected.

While the increase in poultry farms is still a going concern, the major problem in recent times has been the proliferation of proposals for holiday lets, and glamping sites, including caravans, pods, and shepherd huts. Following opposition some have been refused but quite a number have been permitted causing harm to our countryside. The places for them have been widespread over the Bridgnorth area including at Alveley, Astbury, Broseley, Bridgnorth (Knowle Sands), Broseley, Claverley, Eardington, Hampton Loade, Highley, Ludstone and Worfield. The one causing the greatest opprobrium was Astbury Hall, where the creation of over 350 holiday flatlets was allowed.

Another bitter disappointment earlier last year was the granting of permission for excavation at Shipley Quarry, which we consider was contrary to Shropshire Council's own planning policies. It lays open the valid charge that commercial interests come first and care of our countryside a poor second. An ongoing major issue is deciding on the future use of the former Ironbridge Power Station site. It is important to keep an eye when any development proposals are presented and to comment as and when needed.

The Local Plan Review is still underway and creating great local consternation because of the desire of Shropshire Council to build on Green Belt land in quite a number of places, without the 'very special circumstances' justifying the developments.

Garden Villages are proposed at Stanmore and Tong and other large housing developments at Albrighton and Shifnal. They are all hotly disputed at local level. Even the village of Alveley is affected where two fields in the Green Belt are proposed for housing development. These proposals make a mockery of the statements in the revised NPPF issued in July 2018, where it is claimed that it should be more difficult to erode Green Belt boundaries during Local Plan development and that they should only be altered where exceptional circumstances are fully evidenced and justified. Our committee has been represented at local meetings regarding the Review and Place Plan meetings for Albrighton and Bridgnorth.

Our committee has been approached by individuals and pressure groups for help and advice on how to challenge planning applications or the Local Plan proposals. It has been a year of a high number of controversial planning issues and the main difficulty has been dealing with them all satisfactorily.

My grateful thanks go to all committee members for their contributions in pursuing the aims and objectives of CPRE.

## **Poultry Shed update**

The uncertainty of Brexit, farm payments and the government's drive to encourage landowners and farmers to diversify will inevitably lead to continuing and increasing numbers of applications for large agricultural units and also for holiday sites.

In April 2018, Shropshire Council issued guidance notes on assessing the impact of ammonia and nitrogen on designated sites and Natural Assets from new and expanding livestock units. The Council are still granting planning permission for poultry units, but with increased attention to the environmental impact. Shropshire Council granted planning permission for the erection of four poultry buildings at Footbridge Farm, Tasley. As a result of this, the Tasley Chicken Farm Action Group were formed and appealed against this decision. The campaign group stated that it was taking the appeal to the Court of Appeal to ensure that councils across the country do not turn a blind eye to the risk of environmental impact when they consider new applications. The case has been heard and the decision is awaited.

In September 2018, the Council gave approval to four poultry sheds at Hopton Heath, subject to a 106 agreement to remove manure from the Clun catchment area and ensure that the scrubber system remains throughout the lifetime of the development, but as yet no notice has come through. The status of the application is awaiting decision.

In February 2019, the Council granted planning permission for the erection of two poultry sheds to the North East of Aston Munslow subject to certain conditions. As a result, campaigners have decided to look at cross county border implications of all these decisions. Maps will be produced which include all the relevant data pertaining to large chicken farms. The existing CPR Wales maps are being used as a model and it was agreed that it would be effective to combine these maps to include Wales, Shropshire and Herefordshire.

The moral of the story relating to large chicken farms and Shropshire Council would seem to be "if you are against the endless proliferation of these units, contact your local Councillors to make your views known and lobby for a change in policy."

## Did you know? Investigating forgotten paths

There are 130,000 miles of paths across England and Wales, according to the Ramblers' website.

In 2026, as a result of the Countryside & Rights of Way Act 2000, the law will change. Bridleways and footpaths that existed in 1949 but are neither recorded on a local authority's Definitive Map & Statement of Public Rights of Way nor the subject of a Definitive Map Modification Order (DMMO) application to be recorded, will be extinguished and lost forever.

The Ramblers, British Horse Society and other outdoor groups are therefore urging everyone who values our rights of way to research forgotten paths on maps and documents in their local area: "The more people out there scouring libraries and public records offices for documentation, the more paths we can save before the 2026 deadline."
